First draft of the North Coast Marine Plan was presented. Participants were asked to review and provide advice on draft sections including introduction, planning approach, over-arching themes, and issue-specific management direction.

- Members were asked to provide detailed comments on plan text using a provided template.

    - Compliance and Enforcement, Monitoring and Stewardship, Protection, Pollution, Tenured Activities (General Tenures, Renewable Energy, Aquaculture, Forestry Operations), Tourism and Recreation, Fisheries, Governance, Economy and Communities, First Nations Resource Use and Management

### North Coast Marine Plan - Draft 1 Review, continued.

#### **Marine Spatial Planning - Process Review**

Key Discussion Items

- Update on process and timelines for the marine spatial component of the plan. Progress since June MPAC meeting was highlighted.
- First Nations and Provincial technical staff have drafted a special management zone scenario for review, including Recommended Use and Activities tables (RUA) and rationale documentation for each zone.
- First Nations and Provincial technical staff continue to develop zones for protection management, with the intent to present these as a complete marine spatial zoning scenario (including SMZs and zones identified for MPA designation) with Draft 2 of the North Coast Plan.
- Timeline for spatial planning and how it fits into the overall timeline extension for the NC planning process.

#### Key Discussion Items

- Development of RUA tables and how they are structured.
- Clarity around the utilization of RUA Tables in guiding tenure management decision making.
- RUA tables were reviewed for, and advice was provided on:

  - Community Economic
