**MARINE PLANNING PARTNERSHIP FOR THE NORTH PACIFIC COAST
SUPPORT PROJECT MEMORANDUM OF UNDERSTANDING**

Dated effective: December 31, 2013

This amendment pertains to the Memorandum of Understanding between the Government of British Columbia as represented by the Ministry of Forests, Lands and Natural Resource Operations, Coastal First Nations, North Coast-Skeena First Nations Stewardship Society, Nanwaḱolas Council Society and Tides Canada Initiatives Society (the MOU).

As permitted under paragraph 6.2 of the MOU, this document amends the MOU by extending the end date from December 31, 2013 to June 30, 2014 so that paragraph 6.2 of the MOU now reads:

The parties intend this MOU to continue from its commencement until June 30, 2014. This MOU will commence on the date of the last signature.

All other terms of the MOU will remain in effect.
