## Day 1

---

### **Welcoming and Introductions:**

- John Bones and Matthew Justice, Marine Coordination Team and Co-Chairs, welcomed the group on behalf of the Province of BC, First Nation MaPP partners, and the Marine Working Group members and introduced new members Kim Johnson, Adrian Rowland and George Cuthbert.
- Introductions were made around the table (including alternates and MaPP participants) and members spoke about their sectors.
- Craig reviewed meeting and venue logistics.
- Craig reviewed agenda and purpose of the meeting.

### **Marine Planning Partnership (MaPP):**

#### ***Science Coordinator Updates***

- Jo provided an update on three regional outputs/frameworks (zoning, cumulative effects assessment (CEAF) and compliance, monitoring and enforcement) (Presentation: *Updates for RMAC Science Coordinator 20130304\_JLS-1.pdf*)
- Discussion about incorporating zoning comments from RMAC and MPAC members into document.
- Discussion about the province's cumulative effects framework and possibilities for a joint framework.

- Discussion about additional MaPP outputs (vulnerability matrix, climate change and human well-being/governance indicators) and planning tools (InVest and Marine Planning Portal).

### **Sub-regional plan update**

- **Haida Gwaii** –Matthew communicated that this sub-region is working with the province to complete a draft plan by the end of March. This plan is further ahead than the other sub-regions.
- **North Coast** – Matthew communicated that the majority of the objectives and strategies had been presented. In January, the zoning framework was introduced and in March the zoning process would be introduced.
- **Central Coast** – Steve communicated that all the objectives and strategies had been presented. Spatial plan development, zoning designations and planning tools will be presented at the next MPAC in March.
- **North Vancouver Island** – John communicated that preliminary zoning and data sets will be discussed at the next MPAC in March.

#### **Other comments**

- Jo communicated that the sub-regions will have a draft plan ready for the summer.
- Clarification about vertical zoning – MaPP zoning is intended to provide a single recommendation for use that applies to the surface, water column and seabed.

2. Discussion about the current limited enforcement capacity and the necessity for increased enforcement in the MaPP study area.
3. Discussion about measuring the effectiveness of monitoring and enforcement strategies.
4. Discussion about the Guardian Watchmen Program.
5. Discussion about sharing information/data with other agencies/groups and how the information will be managed.
6. Request clarification to identify most recent version of framework document.

### Draft Questions for Monitoring and Compliance

- Steve Diggon presented three questions to the table.
  - Does the document provide an effective framework for developing better monitoring of EBM indicators and targets and more effective compliance, monitoring and enforcement of plans, regulations and laws in the MaPP area?
  - Are there any key elements/ideas/etc. missing from this document?
  - Does this framework effectively incorporate the EBM principles?
