# **Focus Topic: Marine Response Planning**

 After introduction by Steve, Stafford Reid gave two presentations, one focused on Major Marine Vessels in BC's Coastal Waters and Geographic Response Plans for BC's Coastal Waters (Presentation: Coastal Marine Issues MaPP RMAC 2014.pdf). Discussion followed.

#### **Items Discussed and Clarified:**

- 1. Clarification about the nature of the lack of investment in response preparedness, and the scope of the work that MaPP will address in preparing GRPs.
- 2. Clarification of the vision for oversight committees.
- 3. First presentation comments received on mustering points and gaps (e.g., unstaffed lightstations), community and FN expertise, the short window of opportunity to clean shorelines at low tide, logistics of moving workers, frequency of incidents, and application of the bowtie model for risk management.
- 4. Second presentation clarification requested on location for the slide showing projected growth of vessel traffic, discussion of the drivers for GRPs, clarification of the use of the term "geographic."

- 4. Clarification about the purpose of the gap analysis within the scope of MaPP.

# **Focus Topic: Regional Integrated Economic Strategies**

 Jo presented the Regional Integrated Economic Strategies recommendations document (Presentation: EconomicStrategies Recommendations v1.1 201402 JLS.pdf). Discussion followed.

#### **Items Discussed and Clarified:**

- 1. Clarification that Kathy Chopik's report did not address the value of existing economic activities.
- 2. Comments received about business models, for example franchises; the focus of the Coast Opportunities Fund; the marine highway concept and potential inclusion in economic strategies as well as infrastructure;
- 3. Clarification about the scope of MaPP with respect to seafood branding.
- 4. Clarification that the recommendations are limited to marine-based economic activities.
- 5. Clarification that the Regional framework is based on common Sub-regional strategies.

of Federal Reports and Legislative Changes in Pacific Canada Relevant to MaPP. Discussion followed.

- 1. Comments received about transfer of responsibilities from federal to provincial level, challenges in fulfilling international obligations, ways for MaPP to articulate strategies to support international obligations, and exceptions in legislation.

# **Focus Topic: Cumulative Effects Assessment**

• After introduction by Jo, Steve Wilson presented on the Cumulative Effects Assessment Framework he developed for MaPP. Discussion followed.

- Comments received on how EBM values relate to the environmental assessment process, who pays
  for mitigation, scale used to measure cumulative effects, using the CEA framework for
  socioeconomic values, cautions around data sets and the shift from measuring activities to
  measuring values, the importance of who sets the objectives.

- 3. Questions received on pilot project proposal, and whether there has been consideration of changes to current decision-making structures.
- 4. Clarification about why MaPP is concerned with a cumulative effects assessment framework.
