### Welcome and Introductions

- Bruce Watkinson, Executive Director of the North Coast Skeena Stewardship Society, introduced himself as meeting chair, welcomed everyone to the meeting, provided an overview of the meeting agenda, and reviewed the NCIAC operating principles.
- Rachel Post shared the actions from the prior NCIAC meeting, noting that they have been completed.

## **NCCE Program Updates**

- Alli Morrison updated the Committee on progress since the last meeting.
- Committee members were encouraged to circulate the recently completed Backgrounder on the NCCE Program (attached to meeting invite and found in the Dropbox) as a communication tool about the Program.
- Engagement on values work including the Food Security/Access to Resources (FS/ATR) report is anticipated this fall.
- Activities in alignment with the annual workplan are underway.
- Key objective for today is to obtain Committee members' formal advice on the draft NCCE Program Engagement Strategy.

### **Draft Engagement Strategy**

- The draft Engagement Strategy was attached to the meeting invite and circulated two weeks in advance of the meeting.
- Rachel Post provided an overview of the intent and approach for the Strategy. The audience, engagement strategies, approvals, engagement process, challenges and solutions sections in the draft Strategy were informed by prior NCIAC feedback.
  - Audience and Engagement Strategies
    - No comments from the Advisory Committee.
  - Approvals and Engagement Process
    - An NCIAC member noted that public engagement sessions were held by BC and DFO on the Kitsumkalum and Kitselas treaties (with limited turnout). The member noted that the marine planning component of a treaty may have effects on this table and asked how this is being considered. The NCCE team responded that they will take this comment back to the Partners to consider potential interactions.
    - No further comments from the Advisory Committee.
  - Challenges and solutions
    - No comments from the Advisory Committee.
- An NCIAC member posted a question about the status of local government representation on the NCIAC and processes for reporting on NCCE Program outcomes to local governments.
  - Action: NCCE Program team to confirm local and regional government representation on the NCIAC.

## Update on Marine Plan Partnership for the North Pacific Coast (MaPP) Engagement

- Rosalind Barabash, MaPP co-lead for the North Coast, provided an overview of the history of the NCCE Program and MaPP programs, noting that the NCCE Program is a merger of earlier overlapping processes and serves as a sub-regional process under MaPP.
- MaPP Partners will be looking to engage with the NCIAC on some upcoming items:
  - Survey regarding MaPP stakeholder and local government engagement. Expected launch September 2023.
  - Survey in support of revising the MaPP Regional Engagement Plan. Expected launch fall 2023.

- The MaPP Marine Plan is being reviewed. Stakeholder engagement is on the horizon.
